Fund Description

The Low Duration Income Fund is a portfolio that is actively managed and utilizes a broad range of fixed income securities to seek to deliver attractive income while maintaining relatively low interest rate exposure, with a secondary goal of capital appreciation.

This fund seeks to generate a competitive and consistent level of monthly income without compromising total return, while maintaining low interest rate risk. The fund aims to achieve this by employing PIMCO's best incomegenerating ideas across global fixed income sectors with a focus on risk-factor diversification.

The Fund may use or invest in financial derivatives.

This fund is designed to provide steady income: it takes a broad approach to investing in income-generating bonds. The fund utilizes multiple areas of the global bond market, and employs PIMCO's vast analytical capabilities and sector expertise to help temper concentration risks. This approach seeks to provide consistent income with low interest rate exposure over the long term.

ABOUT THE BENCHMARK

Bloomberg U.S. Aggregate 1-3 Years Index represents securities that are SEC-registered, taxable, and dollar denominated with a maturity between one and three years. The index covers the U.S. investment grade fixed rate bond market, with index components for government and corporate securities, mortgage pass-through securities, and asset-backed securities. 




Sector Allocation (Duration in Years)









